

## **“Bosch & SPB Power Tool Pack” Promotion**

### **Terms and Conditions**

1. Information on how to enter form part of these Conditions of Entry. Entry into this Promotion is deemed to be an acceptance of all Conditions of Entry.
2. The Promotion commences on 1<sup>st</sup> October 2019 and concludes 31<sup>st</sup> December 2019 (Promotional Period). The Promotion contains three monthly draws.
