Terms and Conditions

2. Information on how to enter form part of these Conditions of Entry. Entry into this Promotion is deemed to be an acceptance of all Conditions of Entry.
3. The Promotion commences on 1st October 2020 and concludes 30th November 2020 (Promotional Period).
